OPERATION

The light has four switching stages. Press once on the On/Off switch to go to the next setting, the following setting are possible: COB full power - COB half power - torch ON - OFF. Grip the lamp housing and base simultaneously, then rotate magnetic base 180°.

- Charging: Note:
 - All light are partially charged when delivered.
 - Charge the product before use fully.
 - Please do not use the light when charging.
- Please do not leave the lamp be in charging over 24 hours.
- Please do not disassemble the lamp.
- Please recharge the lamp every six months when in stock.

Cleaning:

Allow the light to cool down sufficiently! Clean with a dry or slightly moist, clean, lint-free cloth and a mild detergent if required. Do not use cleaners that contain abrasives or solvents.
